PRIVACY POLICY

This privacy policy ("Policy") describes how YieldPlanet SA. and its related companies ("Company") collect. use and share personal information of consumer users of this website. www.yieldplanet.com and the services provided rendered by the Company thereon (together. the "Service"). This Policy also applies to any of our other websites or services that post this Policy. This Policy does not apply to websites or services that post different statements.

WHAT WE COLLECT

We get information about you in a range of ways. Information You Give Us. We collect your name. postal address. email address. phone number. username. password. as well as other information you directly give us on our Service.

Information We Get From Others. We may get information about you from other sources. We may add this to information we get from the Service. This may include information provided to us by other users of the Service. Information We Get From Public Sources. We may get information about you from public sources. posted on the internet. This information may be obtained using different algorithms. through social media APIs or other sources. This information may include your posts. biographical information. location or any other information. Information Automatically Collected. We automatically log information about you and your computer. For example, when visiting our websites or using the Service. we log your computer operating system type. browser type. browser language. the website you visited before browsing to our website. pages you viewed. how long you spent on a page. access times. and information about your use of and actions on our Service. Cookies and Tracking Pixels. We may log information using "cookies" or "pixel tags." Cookies are small data files stored on your hard drive by a website. Pixel tags are a single pixel. transparent GIF image that added to a web page. We may use session Cookies (which expire once you close your web browser). persistent Cookies (which stay on your computer until you delete them) and pixel tags to provide you with a more personal and interactive experience on our Service. This type of information is collected to make the Service more useful to you and to tailor the experience with us to meet your special interests and needs.

USE OF PERSONAL INFORMATION

We may use your personal information as follows: To operate. maintain. and improve our sites. products. and services. To process and deliver contest entries and rewards. To respond to comments and questions and provide customer service.
